The Silveira family has helped CPPA present hard working and dedicated pork producers who are pursuing a college education with financial assistance. The award will be given to the most qualified recipient and awarded at the 2017 Pork Spectacular.

Application Requirements:

- Completed Application.
- One page essay on short term and long-term goals along with career objectives, involvement with the California swine industry, work experience, and related achievements and honors.
- One page essay explaining in detail all of your important campus, community and agricultural related achievements, honors, awards and activities (including related work experience).
- Two Letters of Recommendation.
- Copy of Transcripts.

The following shall apply to Scholarship Recipients:

- Funds shall be placed in an account at the school to be attended or attending.
- Funds shall only be applied to school tuition, books, and supplies.
- All or part of these funds may be used at any time during the academic year of award.
- If the recipient fails to maintain a 2.5 overall GPA or a 3.0 GPA in major course study, the remaining funds shall be forfeited and returned to the scholarship fund.
- If the recipient fails to maintain full time enrollment (12 or more units of credit), the remaining funds shall be forfeited and returned to the scholarship fund.
